Sir/Madam,

Online Quotation are invited from reputed manufacturer/Dealer/Supplier in two bid system (Technical bid & Financial bid) for purchase/supply of four numbers Insect Proof Net House on behalf of Director, ICAR-Indian Agricultural Research Institute, New Delhi. The last date for online submission of Bid is 03.12.2020 at 1:00 P. M. The bid will be opened on dated 04.12.2020 at 3:00 P.M. in the Division of Vegetable Science by prescribed committee.

**Quotation shall satisfy the following conditions:**

1. The rates quoted shall be valid for a minimum period of **180** days from the last date fixed for the online submission of bid.
2. The rates quoted shall be for free delivery and installation at four location namely:-
  - (i) Village: Fatehpur, Block: Khair District: Aligarh, Utter Pradesh.
  - (ii) Village: Khera Kisan, Block: Tappal, District: Aligarh, Utter Pradesh.
  - (iii) Village: Jalalpur Karira, Block: Shikarpur District: Bulandshahr, Utter Pradesh.
  - (iv) Village: Samaypur, Block: Rajapur District: Ghaziabad, Utter Pradesh.
3. Bids offered in Indian Rupees on FOR value basis than certificate for concessional GST will be issued by the Institute. However, GST as applicable after concession will be paid by the Institute as per rule.
4. Full specification of the article quoted for shall be given in the quotation along with literature/pamphlet/drawing etc. User list of the quoted item may also be additionally provided for reference.
5. If taxes, duties or any other charges over and above the rates quoted leviable, actual percentage/amount of such taxes/duties/other charges should be clearly indicated.
6. If the bid is submitted by the authorized dealer on behalf of the Manufacturer/OEM, than valid authorization certificate of the Manufacturer/OEM must be attached with the bid, otherwise bid will not be considered.
7. As per CVC's guide lines No. 12-02-6 CTE-SPJ (1)-2/161730 (Circular No. 3/1/12 dated 13/01/12 , in a tender, either the Indian Agent on behalf of the Principal/OEM or Principal/OEM itself can bid but both cannot bid simultaneously for the same item/product in the same tender. Further if an agent submits bid on behalf of the Principal/OEM the same agent shall not submit a bid on behalf of another Principal/OEM in the same tender for the same item/product.
8. Supply is to be made by any convenient mode of transport at supplier's risk unless otherwise specified.

9. In case the material is supplied through an authorized agent, manufacturer shall be responsible for the successful installation of the equipment. The manufacturer shall be liable to any penal action for the shortcomings of the authorized agent. Any payment that is to be made separately to the agent if any shall be clearly mentioned in the quotation.
10. The bid should be accompanied with **earnest money of Rs. 30,000/-(Rupees Thirty Thousand only)** in the form of **D.D. /Pay Order/Fixed Deposit Receipt/Bank Guarantee** from commercial bank drawn in favour of Director, IARI. The original EMD should be submitted to the tender inviting authority on or before last date and time of online bid submission. The detail of DD/Pay order/FDR/Bank Guarantee physically sent should tally with the details available in the scanned copy and data entered during the bid submission time otherwise the uploaded bid will be rejected.
11. No interest on security deposit and earnest money deposit shall be paid by the institute to vendor.
12. The EMD shall be refunded to the unsuccessful bidders after finalization of the quotation. In case of successful bidder, it can be adjusted towards security deposit which is **5-10%** of the order value in the form of **D.D./Pay order/Fixed Deposit Receipt/Bank Guarantee** from commercial bank drawn in favor of Director, IARI and shall remain valid for **60** days beyond the date of completion of all contractual obligation of supplier including warranty obligation for the equipment/goods costing Rs. 1.00 Lakh(Rs. One Lakh) or more. Here would however, be no performance security deposit for equipment/goods costing less than Rs. 1.00 Lakh (Rs. One Lakh).
13. **One year** warranty has to be invariably provided by the firm. In case, there is any variation in the warranty period given in the specification of the item/equipment, the warranty period shall be the final as given in the specification.
14. Payment will be made by mode of e-payment to the supplier/firm after satisfactory completion of work and receipt of pre-receipt bills triplicate. In case of foreign currency payment shall generally be made through LC directly to the manufacturer.
15. The Director IARI, New Delhi reserves the right to accept or reject any or all the quotations either in full or in parts without assigning any reason.
16. Quotations not complying with the above conditions are liable to be rejected.
17. Original EMD shall be send/deposited at administrative office of the Division of Vegetable Science, ICAR- IARI, New Delhi-12.
18. TIN/VAT/PAN/CST /GST Nos. may be given on the Quotation.
19. AMC/CMC charges shall not be included for the evaluation of the financial/commercial bids.
20. Financial Bid will be opened of only those firms who qualify in Technical bid.
21. There will be no exemption for paying earnest money. However, Firms registered with the NSIC only are exempted submitting bids without EMD. (Scanned copy of registration must be attached therewith without which it will not be considered)
22. In case, any dispute arising out of this contract shall be subject to the jurisdiction of Indian laws & court, at New Delhi. Sole arbitrator is appointed by the Director, ICAR-IARI, New Delhi. His decision will be final and binding to both parties (supplier and Purchaser).
23. The successful bidder has to execute the indented material as mentioned in the supply order placed with them within the stipulated period as given in the supply order placed by the unit/Division of this Institute failing which 2% per week and maximum of 10%

deduction as liquidated damage charges will be made from the bill in case the material is not supplied within the given stipulated period.

9. Scanned copy of latest Five years experience for construction of poly house/net house. Copies of supply orders from F.Y. 2015-16 & onwards shall be attached as proof.
10. Scanned copy of ISO certificate.
11. Scanned copy of the last 3 year turnover of the firm. (Minimum Rs. 25.00 lakh) Balance sheets for the last 3 year (2016-17 to 2018-19) shall be attached as proof.
12. Scanned copy of latest income tax return.
13. Scanned copy of compliance statement in accordance with the tender technical specification.
14. Scanned copy of the tender documents duly signed by the concerned firm accepting the same.

Entry Chamber: 2.5m x 2.0m with double door made of GI sq. pipe with polycarsheet covering

Structure: Prefabricated made of ISI marked G I square pipe 47 x 47mm, 38mm x 38 mm, 32mm x 32 mm and 25mm x 25mm ±1mm including cutting, duly bended in required shape, complete as per requirements.

Covering: With UV stabilized 40 mesh insect net fixed with aluminium profile & zigzag spring lock.

Foundation: in cement concrete 1:2:4 (30cm x 30cm x 75cm below GL)

Drip Irrigation System: as per below details

Drip Lateral pipe	: 16 mm LLDPE black
Water Discharge	: 4 OR 2 LPH
Lateral pipe	: 16 mm LDPE black
Quantity/ spacing	: 0.8 m x 0.4 m
Filter	: Disc
