The quotations should reach this office by not later than 14.30 hrs. on **07.09.2018**. The cover containing quotations should be super scribed as "Quotations for **CARBENDAZIM 50%WP** due on **07.09.2018**". Quotations received after the due date will have the risk of not being considered.

The quotations will be opened at 14.30 hrs. on the same day in the presence of the tenders or their authorized representatives, who choose to be present. Quotations shall satisfy the following conditions:

- The rates quoted shall be valid for a minimum period of 90 days from the last date fixed for the receipt of quotations.
- The rates quoted shall be delivery for Destination freight prepaid at Karnal free delivery at the Institute Research Centre IARI REGIONAL STATION, KARNAL .Rates quoted on any other basis shall show the freight charges from the supplier's godown to \_\_\_\_\_ Parcel/Railway Station and extra amount that will be charged towards packing, forwarding, postage etc. The period upto which the rates quoted are valid should be specified.
- Full specifications of the article quoted for shall be given in the quotation along with illustrated pamphlets, drawing etc. where available. Where possible samples should also be sent.
- If taxes, duties or any other charges over and above the rate quoted are leviable by the purchaser actuals/percentage of such taxes/duties/charges should be clearly indicated.
- Please note that this Institute is entitled to concessional sales tax as applicable to Educational Research Institutions/Laboratories etc. against declaration form.
- In case any of the item mentioned in the schedule is covered by rate contract of DGS&D etc. the rate contract No. and date may be specified. Supply of a copy of the rate contract A/T would be appreciated.

- Articles of indigenous origin are required except where specified otherwise where indigenous make is not available foreign made articles can be quoted for provided payment is acceptable in Indian Currency.
- Specific mention should be made as to whether delivery will be from ready stock or will have to be imported/required and in the later case the time required for delivery after the firm supply order is placed should be indicated clearly.
- Articles listed in the schedule are required on or before \_\_\_\_\_.
- Validity of Insecticides, Pesticides/ fungicides/ weedicides/ fertilizers etc. should be minimum of 18 months. It should be of ISI Mark as well as from standard firm.
- Scanned copy of GST/TIN/VAT/PAN/C.S.T. Nos (As applicable) may be attached with the bid.
- Quantity mentioned approximately which may be increase or decrease at the time of order given.
- Supply is to be made by goods train or by road transport whichever is cheaper at supplier's cost unless otherwise specified.
- Quotation shall be complete in all respects viz., minimum units of supply, specifications, rate actual percentage rate of taxes, duties made of dispatch etc. If installations are to be done by the supplier, it should be specified and extra charge, if any, payable thereon be clearly mentioned in the quotation. Rebate, if any allowed if large quantity is ordered may also be indicated.
- In the case of equipments, one year warranty certificate has to be invariably furnished.
- Payment will be made by mode of e-payment to the supplier/firm after satisfactory completion of work and receipt of pre-receipted bills in triplicate.
- The Head, IARI, Regional Station, Karnal reserves to himself the right to accept or reject any or all the quotations either in full or in part without assigning any reason.
- Enquiries about the fate of the quotations will not be entertained.
- Quotations not complying with the above conditions are liable to be rejected.
