Sir,

Online bids are invited in two bid system (i) Technical bid (ii) Financial bid on behalf of Director, ICAR-IARI, New Delhi from eligible bidder for “**Transportation of Small Agricultural Machinery**” purchase/hiring/Service for “**Transportation of Small Agricultural Machinery**”. The last date for submission for above bid through online is **27th February, 2020 up to 1300 hours**. The technical bid will be opened on **28th February, 2020 at 1500 hours**. **Pre-bid conference for any clarification will be held on 14th February, 2020 at 2.30 PM in Division of Agricultural Engineering IARI, New Delhi.**

Instructions to the bidder and terms & conditions of tender:

1. The rates quoted shall be valid for a minimum period of **180 days** from the last date fixed for the receipt of quotations.
2. The rates quoted shall be final and inclusive of loading, unloading charges and delivery at the installation site (As given in Annexure-I).
3. Full specifications/details of the article quoted/service provided for shall be given in the quotation along with Supporting documents/literature/pamphlet/drawing etc. User list of the quoted document may also be additionally provided for reference.
4. If taxes, duties or any other charges over and above the rates quoted leviable, actual percentage of such taxes/duties/other charges should be clearly indicated.
5. Supply is to be made by any convenient mode of transport at supplier’s risk unless otherwise specified.
6. Transport firm will be responsible for the safety of the cargo in all circumstances and handling complete and proper papers.
7. The Director, ICAR-IARI reserves the right to accept or reject any or all the tenders received, without assigning any reason.
8. The successful tenderer will have to give an undertaking that no consignment of ICAR-IARI will be detained/withheld by them before or after the clearance under any circumstances.
9. The Director, ICAR-IARI, New Delhi reserves the right to terminate the contract/Order on one month’s prior notice at any time on finding the service unsatisfactory or on breach of contract/Order.

10. Bids of firms who have not executed any contract satisfactorily, failed to execute any such contract have/poor tract record shall not be considered. Misrepresentation or suppression of acts will lead to cancellation of the bid and forfeiture of the EMD.
11. Except where otherwise provided in the clauses of this contract or the execution of the same arriving during the progress of work after the completion, abandonment thereof all disputes shall be referred to the sole arbitration of a person nominated by the Director General, ICAR and if he is unable or unwilling to act, to the sole arbitration of other person appointed by him willing to act as an arbitrator. The submission shall be deemed to be submission arbitration under the meaning of the Arbitration Act 1940 or any statutory modification of re-enactment thereof for the time being in force. The award of arbitrator so appointed shall be final, conclusive and binding on all parties to this contract.
12. All disputes to be settled under New Delhi Jurisdiction.
13. In case of any confusion, the parties should seek clarification about terms and conditions and pattern of formats, instead of quoting in ambiguous manner.
14. The bid should be accompanied with earnest money of **Rs. 30,000/- (Rs. Thirty Thousand only)** in the form of D.D./Pay Order/ Fixed Deposit Receipt/ Bank Guarantee from commercial bank drawn in favour of Director, ICAR-IARI payable at New Delhi as mentioned against each of the item/equipment together with the technical bid, in the absence of which the price bid, if any, will not be opened under any circumstances.
15. No interest on security deposit and earnest money deposit shall be paid by the Institute to tenderer.
16. The EMD shall be refunded to the unsuccessful bidders after finalization of the quotation. In case of successful bidder, it can be adjusted towards security deposit which is **5-10%** of the order value in the form of D.D./Pay Order/ Fixed Deposit Receipt/Bank Guarantee from commercial bank drawn in favour of Director, IARI payable at New Delhi and shall remain valid for 60days beyond the date of completion of all contractual obligation of supplier including warranty obligation for the equipment/goods costing Rs.1.00 lakhs (Rs. One Lakh) or more.
17. Payment will be made by mode of e-payment to the supplier/firm after satisfactory completion of workafter challan copy verification and receipt of pre-receipt bills triplicate.
18. The Director IARI, New Delhi reserves the right to accept or reject any or all the quotations either in full or in parts without assigning any reason.
19. The firm should have sufficient experience in transport service (Attach proof)
20. Pre-bid conference for any clarification will be held on **14thFebruary, 2019** at 2.30 PM in **Division of Agricultural Engineering IARI, New Delhi.**
21. Scanned copy of GST/PAN Nos as well as EMD must be uploaded through online bid.
22. In case, any dispute arising out of this contract shall be subject to the jurisdiction of Indian laws & Court at New Delhi. Sole arbitrators appointed by the Secretary, ICAR, NewDelhi. His decision will be final and binding onboth parties (Supplier and Purchaser).
23. The firm should have minimum 3 years' experience in concern area from the current date for transportation in North East regionof India (attach the scan copy of work experience).
24. Quotations not complying with the above conditions are liable to be rejected.
25. **Rates should be quoted as per BOQ 1 on-line.**
26. **Document to be uploaded should be signed by company/firm seal in all pages by the firm.**
